#### INTRODUCTION

For the purpose of Positive Pay file transmission, City National Bank offers a secure website, known as the Positive Pay System Access, which allows you to submit files for processing. The instructions below will explain the simple steps necessary to review the exception items generated and make pay or return decisions.

#### Naming Upload Files

The name used for your file is very important to ensure your items are entered into our system. All files uploaded must include the company code assigned by City National Bank and be named as follows "PMMDDYYNNN## txt"...


- · Each File name should begin with the letter "P" to indicate a Positive Pay file.
- MMDDYY represents the two digit month, two digit day and two digit year of information within the file
- NNNN represents your organization's unique company code used to login to the Positive Pay system
- ## Optional discretionary unique identifier for the file
- ".txt" Indicates a text formatted file which should be used for all incoming data files.


#### **Reviewing Exception Items**
