THIS ASSIGNMENT OF TRADEMARKS ("Assignment") dated as of January 19, 1999 from **FLORIDA MARLINS BASEBALL, LTD.**, a Florida limited partnership (the "Partnership"); **FLORIDA MARLINS, INC.**, a Florida corporation and Managing General Partner of the Partnership ("Marlins, Inc."); **HUIZENGA HOLDINGS, INC.**, a Florida corporation and General Partner of the Partnership ("Holdings"); **FSL BREVARD MARLINS CORP.**, a Florida corporation ("Brevard Marlins Corp."); **FLORIDA MARLINS OF BREVARD, LTD.** a Florida limited partnership ("Brevard Marlins, Ltd."); **FLORIDA MARLINS OF BREVARD, INC.**, a Florida corporation and General Partner of Brevard Marlins, Ltd. ("Brevard Marlins, Inc.") (Partnership, Marlins, Inc., Holdings, Brevard Marlins Corp., Brevard Marlins, Ltd., and Brevard Marlins, Inc. are each individually an "Assignor" and collectively are the "Assignors") to **F.M.B.C. II, L.L.C.**, a Delaware limited liability company (the "Assignee"), pursuant to that certain Asset Purchase Agreement dated as of January 19, 1999 ("Agreement"), by and among Assignors and Assignee, providing for the purchase and sale of substantially all of the assets of the Assignors used in the ownership and operation of the (i) Florida Marlins baseball team and (ii) Brevard Manatees baseball team (collectively, the "Business").

WHEREAS, each of Assignors desires to grant and Assignee desires to acquire an assignment of the Trademarks and other Intellectual Property.

NOW THEREFORE, in consideration of the mutual promises contained in this Assignment and for other good, valuable and sufficient consideration, the receipt of which is acknowledged, the parties to this Assignment, intending to be legally bound, agree as follows:


2. **Benefit.** This Assignment shall be binding upon, and inure to the benefit of, the Assignors and Assignee and their respective successors and assigns.



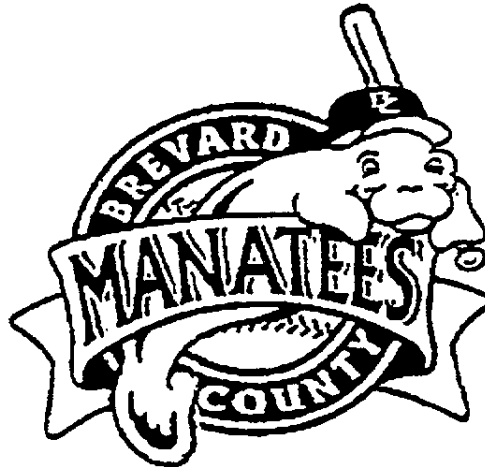
