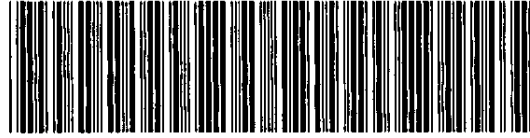

Dear Ms. Causseaux:

We are in receipt of your letter dated July 22, 2016 (a copy of which is attached for your convenience).

The letter addresses the need for a disclaimer statement relating to the term "CLUB". Accordingly, Applicant has completed the disclaimer statement in #2 of Part II in the enclosed corrected application.

The letter states that classes "42, 43 and 35" would appear applicable and requests an additional fee of \$87.50. It is unclear how class 42 would be applicable since class 42 pertains to scientific and technological services and research and design relating thereto, industrial analysis and research services, and design and development of computer hardware and software. Applicant believes this may have been a typo. If you believe class 42 is appropriate, Applicant respectfully requests an explanation.

The letter also requests specimens for "food services" and "country store services". Applicant's food and country store services are ancillary to its services of organizing community fall festivals. As such, Applicant has amended the listing of services on the enclosed corrected application to remove the portion that references food and the country store. Because the reference to food has been removed,
