
We have a fictitious name for Miami's Community Newspapers that we recently filed, as well as one we filed many years ago.

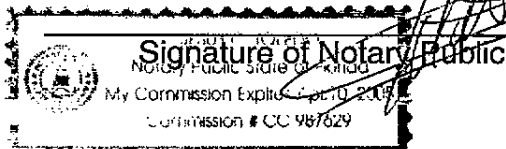
