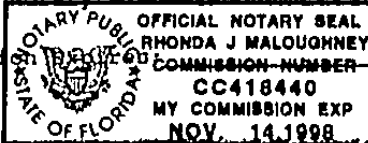

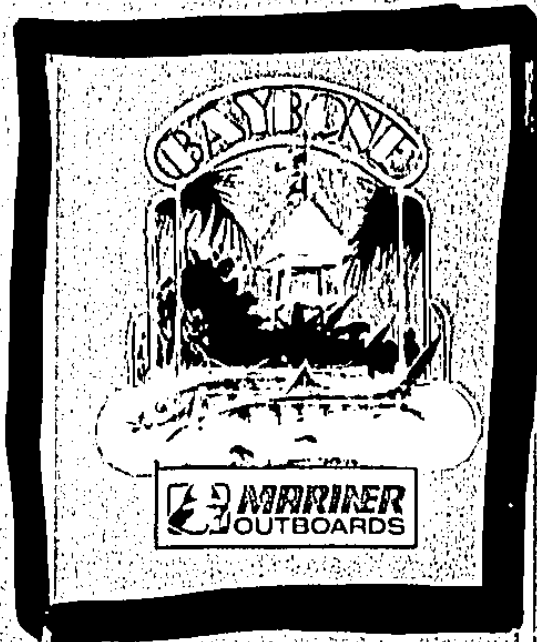
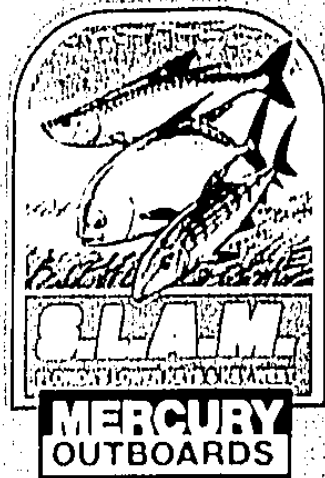

Therefore, it is important to test for stationarity before conducting the regression analysis. The results of the stationarity tests are reported in Table 2. The results show that the data are stationary at the 1% level of significance. Therefore, the results of the regression analysis are valid.
