We are in receipt of your letter of August 10, 1995, copy enclosed, wherein registration in Florida for ACCESS was refused based on several federally registered marks.

We respectfully urge reconsideration of registration, first, based on the enclosed documentation reflecting that the federally registered marks are used in connection with separate goods and services from those of applicant's. Simultaneous use of the mark ACCESS in commerce for the goods and services recited in the application before you is not a competitive use to the use by the registrants' of the trademarks you cited in your letter of August 10, 1995. As a result, no confusion in the market would result because of the use of the mark ACCESS by our client.

Additionally, we note that section 495.021(1)(f), Florida Statutes, is silent with respect to refusing registration in Florida based on federally registered marks. A mark that is registered in the U.S. Patent and Trademark Office does not necessarily mean that it is in use in Florida or, indeed, in actual use at all.

Section 495.181, Florida Statutes, specifies that the intention of the Florida Legislature was to give great weight to the interpretations of the federal courts and the Lanham Act (15 U.S.C. sec. 1051 et seq.) with regards to registration in Florida of trademarks and service marks.

Registration in Florida of applicant's mark does not violate the Lanham Act. The Lanham Act is silent with respect to registration of state trademarks and service marks. There has also been no federal court determination made on the particular facts involved in this matter. Therefore, if there is no prior Florida registration for ACCESS (or a mark that so resembles August 18, 1995 Pago 2

ACCESS such that confusion is likely) the applicant should not be denied registration in Florida.

We therefore submit the applicant's mark is entitled to registration in Florida.

This letter follows your telephone discussion yesterday with Angela Malloy of this office regarding the above-referenced matter.

As discussed, we received your letter of August 22, 1995 (copy enclosed) and note that registration of ACCESS in Florida was refused based on a U.S. registration for ACCESS, no. clase 71,694,742, (a listing of which is also enclosed).

The U.S. registration for ACCESS was granted for use in connection with services in international classes 35 and 38 only. The Florida application we submitted for filing was not only for services in international class 38, but also for goods in international class 16. Therefore, trademark registration in Florida should not have been refused in international class 16 based on a U.S. service mark registration in international classes 35 and 38.

In accordance with your recommendation and Section 495.181, Florida Statutes, we hereby request reconsideration and respectfully urge registration of ACCESS in Florida, at least in international class 16.
