

**ORDER ON PETITION FOR DISSOLUTION OF AGRICULTURAL
COOPERATIVE MARKETING ASSOCIATION**

Hearing having been held on the aforementioned matter on September 4, 2003, and the court having been sufficiently advised in the premises,

IT IS HEREBY ORDERED AND ADJUDGED as follows:

1. That Premier Citrus, L.L.C. is the sole owner of all property subject to the covenants of River Gem Growers Cooperative, Inc., a Florida Agricultural Cooperative Marketing Association.
2. That the requirements of membership in said Cooperative are that to be a member of the Cooperative, the party must be an owner of part of the citrus grove located in St. Lucie County, formerly known as Golden Gem Grove.
3. That as a result of the Petitioner's purchase of all of said land in that grove, Petitioner has become the sole shareholder in River Gem Growers Cooperative, Inc., a Florida Agricultural Cooperative Marketing Association.

THEREFORE, upon the Petition of Premier Citrus, L.L.C., and based upon the preceding findings and the law of the State of Florida, the Agricultural Cooperative Marketing Association formerly known as River Gem Growers Cooperative, Inc., a Florida Agricultural Cooperative Marketing Association, is hereby dissolved and all assets thereof are hereby transferred to Premier Citrus, L.L.C., subject to Florida Statute 618.25, and publication shall be unnecessary.
