ON JUNE 24 I RECEIVED A PHONE CALL FROM THE SHERIFFS DEPARTMENT IN MONT EAGLE, TENN. MY SISTER IN LAW HAD BRUTALLY BEEN MURDERED IN HER OWN HOME AROUND 3:00 AM IN THE MORNING.
