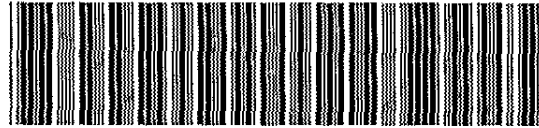

The undersigned director of T. S. Chechele, P.A. hereby amends the Articles of Incorporation of the Corporation to read as follows:


**ARTICLE I - CORPORATE NAME**
