This letter is to request an abatement of the penalty fees being imposed on my client due to a late filing of this form.

We believe there are mitigating circumstances that divert fault for the late filing from the corporation Mowaffak Atfeh, M.D., P.A. and place it on uncontrollable circumstances related to the transition from one accountant to another.

In 1998 I became the corporations successor accountant after the terminal illness of the corporations former accountant. He was also the corporations registered agent and annual reports were sent to his office.

In 1999 the office of the former client was closed and we believe the annual reporting from was sent there and subsequently lost.



Accordingly, we respectfully request that the Department consider these circumstances and abate the penalty fee.
