ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida Business Corporation Act, TAMPA BAY LASER CENTER, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

Name

The name of the Corporation is TAMPA BAY LASER CENTER, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on December 18, 1991.

ARTICLE II

Amendment

Article IV of the Articles of Incorporation of this Corporation is hereby amended for the purposes of increasing the number of authorized shares of common stock to 10,000 shares, effective as of the date hereof by deleting the existing Article IV in its entirety, and substituting the following therefore to wit:

Article IV
Capital Stock

The aggregate number of shares of capital stock authorized to be issued by this Corporation shall be 10,000 shares of common stock having a par value of one dollar (\$1.00) per share."

ARTICLE III

Date of Adoption

The amendment was adopted on the 3rd day of July, 2007.

ARTICLE IV

Manner of Adoption

The amendment was duly approved by the joint written consent to action of the shareholders and the directors of the Corporation.
