1. The Board of Directors of said corporation, at a meeting called and held on the <u>29114</u> day of <u>OCOBER</u>, 2004, adopted the following resolution:

"BE IT RESOLVED by the Board of Directors of Tom Richards, Inc., a Florida corporation, that the article entitled "THIRD" of the Articles of Incorporation be amended, changed and altered so that it reads as follows:

THIRD: The aggregate number of shares which the corporation is authorized to issue is five hundred shares, divided into two classes.
