## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF RECICAR & STARK, P.A.

FILED 97 NOV -3 PM 2: 06 SECRE TARY OF STATE ALLAHASSEE FLORIDA

FIRST: Pursuant to Section 607.1003 of the Florida Statutes, the Articles of Incorporation of Recicar & Stark, P.A. are hereby amended to delete the provisions of Article I as the same now exists, and by substituting in lieu thereof, the following:

## ARTICLE I

## NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be CHARLES H. STARK, P.A.

SECOND: The foregoing Amendment was adopted by a Written Action of All Shareholders and Directors of Recicar & Stark, P.A. on October 29, 1997, which manifests an intent to amend the Articles of Incorporation effective upon the filing of this Amendment with the Secretary of State.
