## THIRD AMENDMENT TO THE ARTICLES OF INCORPORATION OF SGM ENGINEERING, INC.

WHEREAS, the Articles of Incorporation of SGM Engineering, Inc. (the "Corporation") were filed with the Florida Department of State on December 20, 1991, to be effective December 17, 1991, as Document Number V02240, and were amended by a first Articles of Amendment filed on June 2, 1997, and again amended by a second Articles of Amendment filed on January 24, 2008; and

WHEREAS, it is the intention of the sole director of the Corporation that the Articles of Incorporation of the Corporation, as amended, be further amended, effective the date this Amendment is filed with the Florida Department of State, in accordance with the proposed amendments hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Incorporation of the Corporation as hereinafter set forth was approved by written action of its sole director, pursuantito the provisions of Section 607.0821 of the Florida Business Corporation Act on the date of execution below.

NOW, THEREFORE, the Articles of Incorporation of the Corporation, as amended, are hereby further amended effective the date this Amendment is filed with the Florida Department of State, as follows:

- 1. The last paragraph of the Amendment to Articles of Incorporation filed June 2. 1997 is deleted in its entirety.
- 2. As of the date of this Third Amendment to Articles of Incorporation of the Corporation, the sole Director of the Corporation is Bobak Shahnami.

This Third Amendment to Articles of Incorporation was adopted by the sole director and shareholder action was not required, pursuant to Florida Statutes 607.1002(4).
