ARTICLE II - AUTHORIZATION


Dissolution was authorized on December 29, 2000.

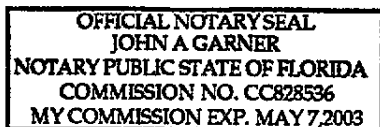
