ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
QUANTUM FINE CASEWORK, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Quantum Fine Casework, Inc. (the "Corporation"), Charter # V03873.

2. The following Amendment to the Articles of Incorporation was adopted by all of the Directors of the Corporation and the Shareholders of the Corporation, the number of votes cast being sufficient for approval, on September 29, 2005 in the manner prescribed by Section 607.1003 of the Act.

3. Article 1 of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article 1, as follows:

"ARTICLE 1"

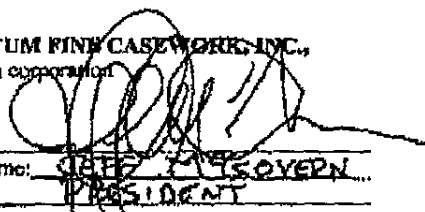
The name of the Corporation is QFCS, INC. (the "Corporation").
