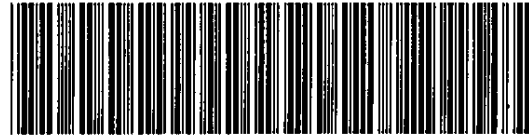

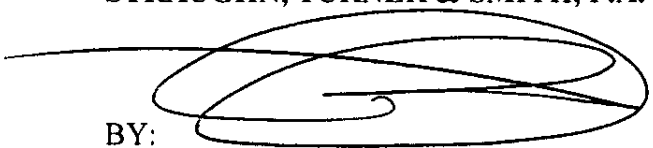

The name of this corporation is STRAUGHN, TURNER, & SMITH, P.A.

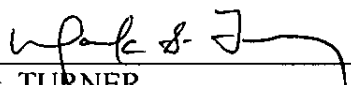
