

We assume at this time the original 1996 filing was sent back to the Conner's address since the new registered agent had not signed on line 11. The check was written on the old bank account which my client, Mr. Bass, had not received any statements on.

It is for these reasons we would ask for an abatement of the \$585.00 reinstatement fee and will forward a check to cover the 1996 and 1997 corporation return.
