
Dear Clerk:

In connection with the above referenced matter, please find enclosed an executed Corporation Reinstatement Form and a check in the amount of \$600.00 payable to the Department of State to cover the reinstatement fee.

A clerk from your office informed me that the State's records indicate that both notices of administrative dissolution of Barrier Free Systems, Inc., which were mailed from the State were returned to the Department of Corporations undelivered.
