Dear Mr. Graves,

It has been brought to the attention of the Department of State, Division of Corporations, that service of process cannot be served on Jill E. Kaufman as registered agent for R.B. GRAVES & SON, INC., at the address of 1061 East Indiantown Road, Jupiter, FL. 33477. In accordance with section 48.091, Florida Statutes, "every corporation shall keep the registered office open from 10:00 a.m. to 12:00 noon each day except Saturdays, Sundays, and legal holidays, and shall keep one or more registered agents on whom process may be served at the office during these hours".


