**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
TRANS WORLD TEMPORARY SERVICES OF TAMPA, INC.**

1. The name of the corporation prior to this Amendment is: Trans World Temporary Services of Tampa, Inc.
2. This Amendment changes the name of this corporation to TransWorld Temporary Services of Tampa, Inc., and, therefore, old Article I of the corporation's Articles of Incorporation is hereby deleted and new Article I is added and shall read as follows:

ARTICLE I - NAME

The name of the corporation shall be: "TRANSWORLD TEMPORARY SERVICES OF TAMPA, INC."

3. The foregoing Amendment was adopted by the board of directors of the corporation and by the shareholders of the corporation on April 13, 1999, by unanimous consent.
