To Whom It May Concern:

I am returning my corporation's annual report along with the original filing fee of \$150.00. Upon receiving my initial notice I promptly sent in the completed form with the required \$150.00 filing fee. However, approximately one month ago I received an additional form stating that I still needed to file my annual report and that I now owed \$550.00, which was inclusive of a \$400.00 late fee. Upon review of my records we realized that the original check for \$150.00 had never cleared. Since the second notice was my first notice that the original report and check were not received, I can only surmise that the original filing and check was lost either in the mail or in the processing. I have no proof of this because the originals of both documents were enclosed in the original mailing. I stated all of this in an informal letter sent with my readmittance approximately two weeks ago, however that was sent back to me with a rejection. I followed up that with a phone call to your office and spoke with "Andy" who encouraged me to send another letter stating my case for the original fee to be accepted.

I must confess that Rocksling Inc is but a one man operation that was born out of a dream of mine to start my own company. However that dream has not proved profitable as of yet and the corporation has yet to produce any revenue. It has been in existence for six years and we have dutifully payed the annual fee each year without exception. However, if I am forced to choose between paying \$550.00 to maintain a floundering company or dissolving the corporation, I am afraid I will have to choose the later. The idea of continuing to maintain the corporation in face of such a exorbitant fee would not be prudent. It is my hopes however that I will be able to make this dream happen and therefore I would like to maintain the integrity of the corporation for in hopes that at some point and tim I can make it work. As a result, I am re-submitting the report with the original filing fee, in hopes that you will accept it. If that is not possible please notify me and let me know what steps I need to do in order to dissolve the corporation.
