I represent both of the above named corporations as well as their principal, Mr. Clodomir Rocha Girao.

As your records will indicate, Ultraville, Inc was recently dissolved as a result of its failure to maintain a registered agent. This failure was completely unknown to my client until he received the enclosed letter from his prior attorney, John H. Friedhoff. According to my understanding of events my client discharged Mr. Friedhoff and soon thereafter Mr. Friedhoff filed with your office his resignation as the corporation's registered agent. He never advised my client of this action nor of the necessity of appointing a new registered agent. Since the corporation's address continued to be Mr. Friedhoff's law firm (275 N.W. 1<sup>st</sup> Avenue, 11<sup>th</sup> Floor, Miami, Florida 33128-1835) it was to this address that your office presumably sent notification of intent to dissolve. Again Mr. Friedhoff chose not to notify my client until the dissolution was formally effected. My client has been severely prejudiced by his former attorney's actions. In light of the foregoing my client is requesting that his corporation be reinstated without penalty assessment.
