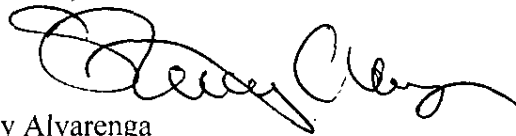

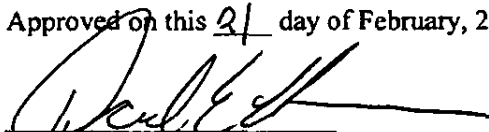

ARTICLES OF DISSOLUTION

4. Non-voting groups were not required to approve the dissolution of the Corporation.

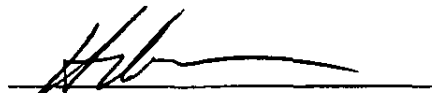
