
Dear Sir or Madam:

Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of Southeast Property Data Services, Inc., a Florida corporation, filed on January 24, 1992, with the Florida Secretary of State, Tallahassee, Florida, is hereby amended as follows:

1. Article I is amended to change the name of the Corporation to the following:

SAMCO SERVICES, INC.

The foregoing amendment was adopted by the Board of Directors of the Corporation on the 29th day of October, 1999, without shareholder action as shareholder action was not required.
