

ARTICLE 1. NAME

The name of the Corporation is *Bottoms Up, Inc.*

ARTICLE II. PURPOSE

The purpose of these Articles is the dissolution of *Bottoms Up, Inc.*


The number of votes cast for dissolution was unanimous and sufficient for approval.
