Pursuant to Section 607.1006(1) of the Florida Statutes, the Articles of Incorporation of Utility Partners, Inc., a Florida corporation (the "Corporation"), are hereby amended as follows:

1. The name of the Corporation is Utility Partners, Inc.
2. Article 1 of the Articles of Incorporation of Utility Partners, Inc. is hereby amended to read as follows:

"ARTICLE 1

The name of this Corporation is:

Technology Management Associates, Inc."

3. The foregoing amendment was adopted on March 6, 1998, by an action by written consent of the shareholders of this Corporation as authorized by Sections 607.1003(6) and 607.0704 of the Florida Statutes.

4. The sole voting group entitled to vote on this amendment is comprised of the holders of common stock, and the number of votes cast for the amendment by such voting group was sufficient for approval by that voting group.
