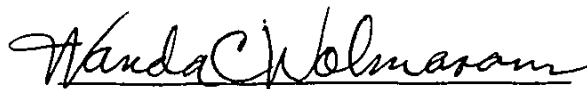

**RESOLUTION TO VOLUNTARILY DISSOLVE THE CORPORATION**

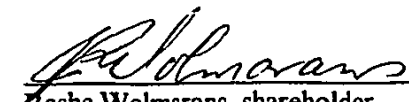
RESOLVED, the shareholders of EASY PUL, INC. have met this 2nd day of May, 1997,  
and by unanimous vote hereby dissolve this corporation.

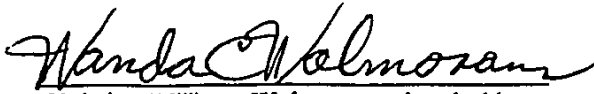
The undersigned shareholders of EASY PUL, INC. have waived all required notice of such

- 4) a majority of the shareholders have authorized this dissolution.

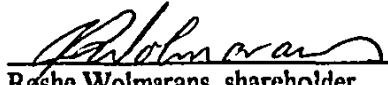
