

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF HAISMAN, APPLEGATE & KINGSTON, INC.



Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its Articles of Incorporation.

The undersigned, being the President and Secretary of Haisman, Applegate & Kingston, Inc., hereby certify that:

- 1. The manner in which this Amendment to the Articles of Incorporation was authorized, was by the Unanimous Written Consent of the Board of Directors of the Corporation, effective September 1, 1998, followed by the Unanimous Written Consent of the holders of all of the issued and outstanding shares of the Corporation, effective September 1, 1998.
- 2. The following Article of the Articles of Incorporation is hereby amended to read in its entirety as follows:

"ARTICLE ONE

The Name of this Corporation is INVESTMENT INSIGHT, INC.."

2. The following Article of the Articles of Incorporation is hereby amended to read in its entirety as follows:

"ARTICLE FIVE

3. The following Article of the Articles of Incorporation is hereby amended to read in its entirety as follows:

The number of Directors of this Corporation shall not be less than one or more than ten. The names and addresses of the Directors of the Corporation are as follows, and shall serve until the next annual meeting of shareholders or until their successors are elected and qualified.
