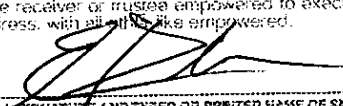

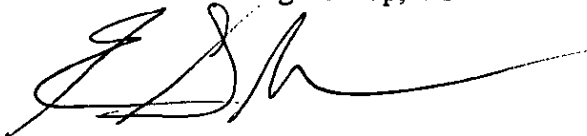

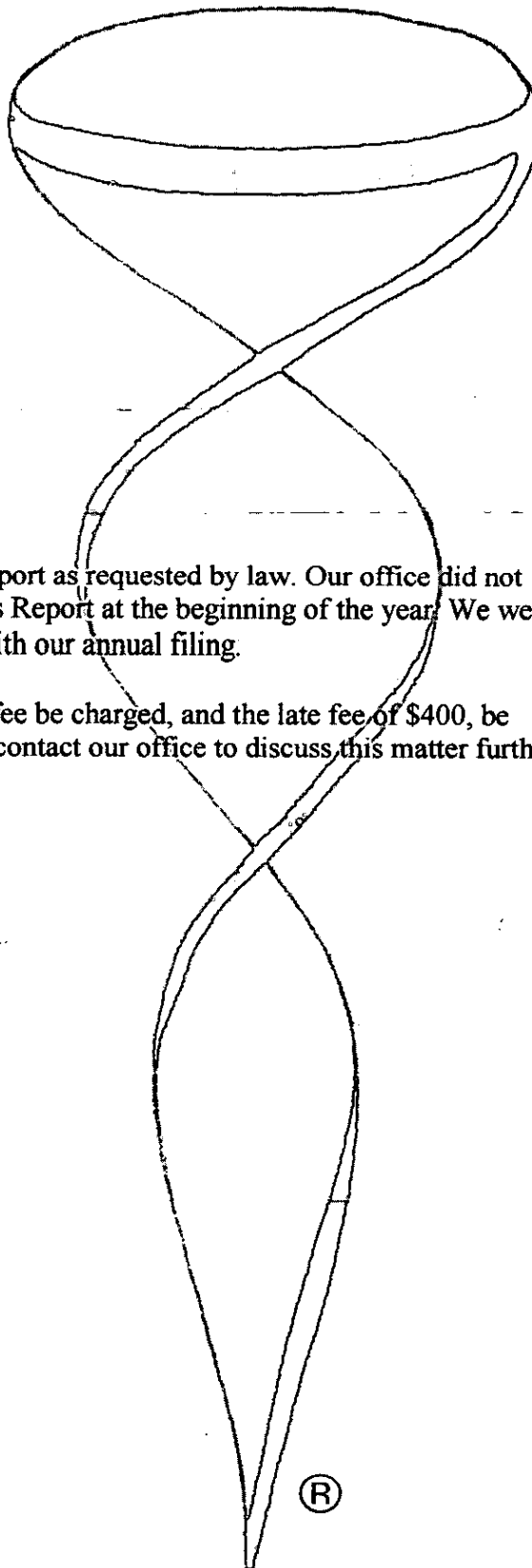
We respectfully request only the \$150.00 fee be charged, and the late fee of \$400, be waived due to the missing UBR. You can contact our office to discuss this matter further.
