ARTICLES OF AMENDMENT FOR ORLANDO RESORT GROUP CORPORATION

Orlando Resort Group Corporation, a Florida corporation, in order to amend its⁴⁴ Articles of Incorporation pursuant to the requirements of Chapter 607 of the Florida Statutes, does hereby submit the following:

1. The name of the corporation is Orlando Resort Group Corporation.

2. The corporation's Articles of Incorporation were filed on February 3, 1992, with the Florida Secretary of State. Article III, entitled "Purposes and Powers", of the corporation's Articles of Incorporation is hereby amended by deleting it in its entirety and substituting in its place the following provisions:

Article III <u>Purposes and Powers</u>

The purposes of this corporation shall be limited to the acquisition, operation, and disposition of the RV/Cottage Resort known as Tropical Palms Fun Resort, located at 2650 Holiday Trail, Kissimmee, Florida 34746, and all property associated with or relating to said resort.

The corporation shall have all the rights, privileges and powers now or hereafter available to corporations for profit under the laws of the State of Florida.

3. The foregoing amendment to the corporation's Articles of Incorporation was approved and adopted by the Board of Directors and all of the stockholders of the corporation, by written consent in lieu of a joint special meeting, on July $J \supseteq \mathcal{D}$, 1997.
