## PLAN OF COMPLETE LIQUIDATION

OF

## SILVER STREAK AVIATION, INC.

This Plan of Complete Liquidation (the "Plan") of SILVER STREAK AVIATION, INC., a Florida corporation (the "Company"), is intended to accomplish the complete liquidation of the Company in conformity with Sections 331 and 336 of the Internal Revenue Code of 1986, and is as follows:

- 1. The Plan shall be and become effective upon the approval and adoption thereof by the affirmative vote of a majority of the holders of the outstanding shares of stock of the Company or the execution of the written consent of all the shareholders of the Company to such effect.
