**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
NATURE BY DESIGN, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, NATURE BY DESIGN, INC., a Florida corporation, (the "Corporation"), does hereby amend its Articles of Incorporation to change its name as follows:

1. The name of this Corporation is DESIGNATED SPORTS, INC.
2. The amendment adopted is an amendment to Article 1 of the Articles of Incorporation of this Corporation deleting such first Article in its entirety and substituting in its place as follows:
Article 1.

3. The new Article 1 shall read as follows:

4. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.

5. The Shareholders and Board of Directors of the Corporation, by a number of votes sufficient for approval, adopted and approved a resolution setting forth the proposed amendment in a written Action in lieu of a formal meeting of the Board of Directors on the 9 day of May, 2001.
