FIRST: The Corporation is hereby dissolved.

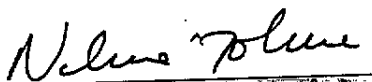

FOURTH: The Corporation has no known creditors.

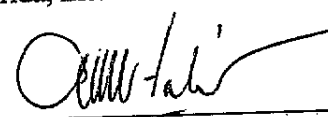
