Article III

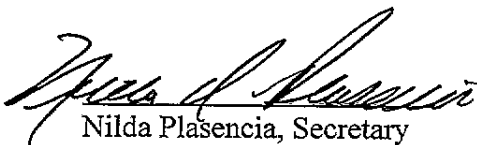
