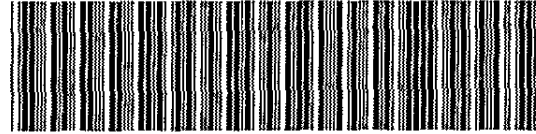

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendments to its Articles of Incorporation.

NEW CORPORATE NAME:

Steven Ettlinger, Inc.

AMENDMENTS ADOPTED:

To be Amended to Read as follows:

ARTICLE I - NAME

The name of the corporation is Steven Ettlinger, Inc.

ARTICLE IV - NUMBER OF SHARES

The aggregate number of shares which the corporation is authorized to issue is one hundred thousand (100,000) shares. Such shares shall be of a single class, and shall have a par value of 10/100 (\$0.10) dollars.

The consideration to be paid for each share shall be payable in lawful money or property, labor or services.

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than ten (10) persons. Stock will be issued and transferred only to (1) natural persons, (2) estates, or (3) a trust as described in title 26 United States Code Section 1371 defining a qualified "small business corporation." In addition, no stock shall be issued or transferred to a nonresident alien.
