Reference our telephone conversation of this date concerning the tardiness of our Corporate renewal for Marion Metal Works, Inc. and Seminole Fire Apparatus, Inc.. As was stated to you, our renewal forms were inadvertently placed in with other "tax type" papers and forwarded to our Daytona Beach CPA. This occurred in a time frame prior to the latter part of March.
