Attached, please find our Annual Report for 2002 and the filing fee of \$150.00.


We did not receive the usual mailing of the UBR forms, which normally come early in the calendar year and therefore overlooked the need for filing.

We did not receive the forms because the mailing address was not updated properly. We sold a retail business at 1401 N. Missouri Ave. Largo (in September 2000), which had been our corporate mailing address for years. The following January (2001) we filed a name change amendment changing the name to Solar Signals, Inc. and including the new mailing address as a part of the accompanying correspondence.

When we received confirmation from the Department of State (attached) it was mailed to the proper mailing address (312 Mariva Ave, Clearwater) so we assumed everything was proper. Now I check the Sunbiz website I see the old corporate mailing address in Largo. No doubt the UBR forms were mailed to the old address and never forwarded to us.

Since we advised you of the change of address in writing and you acknowledged said change, I feel our failure to receive the UBR forms was the result of an oversight on the part of the Department of State. Therefore, I respectfully request that the penalty fees be waived.
