WHEREAS, the purposes for which PARMAT, INC. were founded no longer exist as a business opportunity;


WHEREAS, all the debts of the corporation have been satisfied and the remaining assets distributed; and

WHEREAS, that after proper notice and the unanimous vote of the shareholders, it was approved to dissolve the corporation.


NOW THEREFORE, be it resolved:






