The undersigned subscriber(s) to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

I
NAME

The name of the corporation is: GARRETT LAWN & LANDSCAPING, INC.

II
NATURE OF BUSINESS

The general nature of this business to be transacted by this corporation is:

1. To engage in any activity or business permitted under the Laws of the United States and of the State of Florida.

FURTHER, and not by way of limitation of the preceding paragraph:

2. 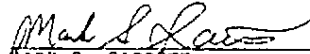

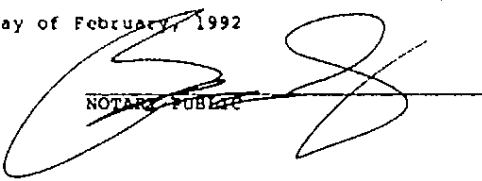

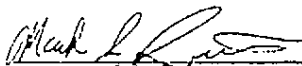
