**Enclosed please find the 2000 Uniform Business Report together with a money order for \$150.00.**

**It has come to my attention that I have made a terrible mistake and I am looking to you for some help and guidance.**

**I am a recent breast cancer survivor (diagnosed in late 1998) and my sister (Susan Rogers) is a recent colon cancer survivor (diagnosed in 1999). My sister has been living with me for the last nine months and I have been taking care of her paperwork in addition to my own personal and business paperwork.**

**When I went to update my books yesterday, I found the 2000 Uniform Business Report attached to some other papers. The only thing that I can think happened, is that when I first received the report, I did not recognize it as the annual corporation report and filed it to look at later. However, somehow I never went back to look at it and I have now been informed that the corporation has been dissolved. I am in a state of panic and am physically ill from this error on my part. I have been advised by one of your representatives to see if it is possible to reinstate the corporation this one time.**

**If you need to document what I have stated, you have my permission and my sister's permission to call our oncologist, Dr. Eduardo Garcia, of the Comprehensive Cancer Center in West Palm Beach. In order to save my life, I was entered into a research program with Emory College called "Dense Dose Chemotherapy" which you should be able to also access on the internet if you need further documentation.**

I am imploring you for any help you can extend regarding this matter.  
I am terribly sorry that this happened, but it was truly a poor error of  
judgement on my part regarding the initial filing of my paperwork.  
Please, please do all possible to correct this terrible error.
