THE UNDERSIGNED does hereby certify that **HEALTH WATCH**, INC., (the "Corporation") originally was incorporated in the State of Florida on March 13, 1992, and that this Restated Articles of Incorporation is being filed in accordance with the provisions of Section 607.1008 of the Business Corporation Act of the State of Florida, as amended (the "BCA"), and further certify that:

FIRST: That the United States Bankruptcy Court for the District of New Jersey, Camden Division (the "Court"), by entry of a confirmation order on October 18, 2002 (the "Confirmation"), approved the Corporation's plan of reorganization.

SECOND: That the Court, by entry of a bankruptcy court order dated October 28, 2002 (the "Order"), approved this Restated Articles of Incorporation contained herein;

THIRD: That the title of the reorganization proceeding in which the Confirmation and the Order were entered was: In re Response USA, Inc., <u>et al</u> Case No. 01-18703 (GMB) (the "Proceeding"); and
