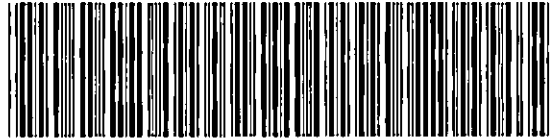

Article I


