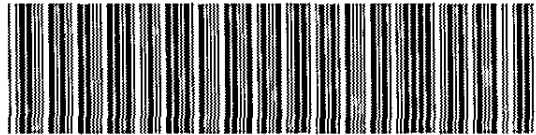

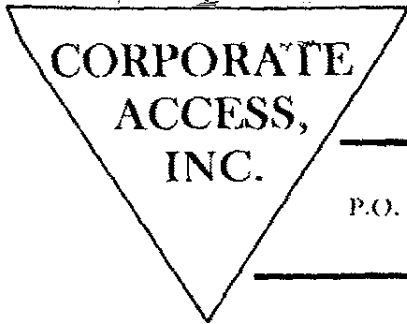

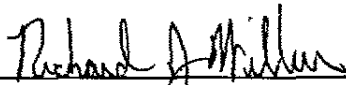

3. The foregoing Amendment was adopted by the unanimous consent of the Board of Directors and Shareholders of this Corporation on the 12 day of July, 2007.

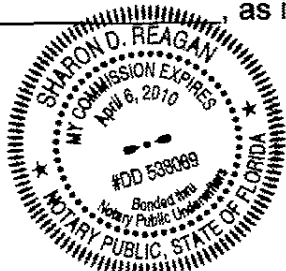
