## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION



Pursuant to §607.1006 Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST. The name of the Corporation is Fredrick D. Shaffer, P.E., P.A.

SECOND. Article I of the Articles of Incorporation is amended to read as follows:

## "ARTICLE I NAME

1.00 The name of the corporation shall be Fredrick D. Shaffer, P.E., Inc."

THIRD. Article III of the Articles of Incorporation is amended to read as follows:

## "ARTICLE III PURPOSE

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act."

FOURTH. Article VIII of the Articles of Incorporation is amended to read as follows:

## "ARTICLE VIII POWERS

The corporation shall have all the corporate powers enumerated in the Florida Business Corporation Act or otherwise as provided by law."

FIFTH. Article XIV of the Articles of Incorporation entitled "Restrictions on Transfer of Shares" is deleted.

SIXTH. The above amendment was adopted by the Shareholders of the Corporation on the day of AUGUST, 2002.
