ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ANALYTIC APPARATUS CORPORATION

Any director of this corporation may vote upon any contract or other transaction between this corporation and any firm, association or corporation in which he may be anywise interested.
