I AM NOT THE RECIEVER OF THE CORPORATE MAIL AS SUCH AND WAS NOT AWARE OF THIS  
PROBLEM.

THE REFER TO MAKER STAMP WAS DUE TO AN INTERNAL THEFT PROBLEM WE HAD WITH MISSING  
CHECKS. NOT FRAUD, HOWEVER A NUMBER OF CHECKS FOR OUR CHECK BOOK WERE MISSING.

WE ARE ENCLOSING A CASHIERS CHECK FOR THE AMOUNT OF \$ 175.75. TO PAY THE FEE IN FULL.

WE ASK YOU WAIVE ANY FURTHER CHARGES OR PENALTIES DUE TO MY PERSONAL LACK OF  
NOTICE.

WE HAVE INITIATED A NEW SYSTEM OF MONTHLY POSTINGS TO AVOID FURTHER PROBLEMS IN THE  
FUTURE.

PLEASE ACCEPT OUR REMITTANCE AND RE-INSTATE OUR CORPORATE CHARTER.
