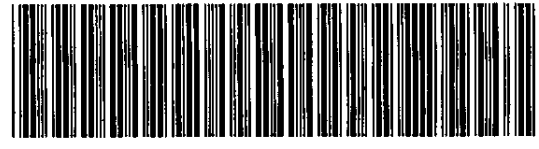

The shareholders authorized the dissolution of the corporation at a meeting held April 14, 2016.

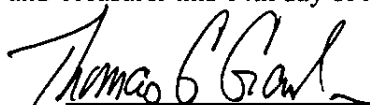
Article III - Effective Date

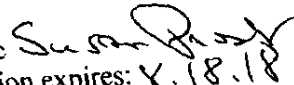
