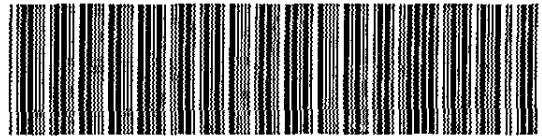




ARTICLE I
