On January 3 of this year we completed, signed, dated, and mailed the Annual Report for our corporation (see attached copy).


Also on January 3 of this year we included with the report our check number 1258 for \$165.00. A copy of our check register is enclosed. Check #1258 is the third item from the bottom.
